



#### THAT:

1. If, subject to visa control, persons forming part of the entire FIFA delegation, FIFA's commercial affiliates, the broadcast rights holders, including the host broadcaster, the delegation from the finalist national associations, the Official FIFA partners, the Official LOC Suppliers, the media representatives and the foreign visitors to the 2010 FIFA World Cup, having applied timeously for visas and having paid the required visa fees and not being prohibited persons in terms of the Immigration Act of 2002, will be issued unconditionally with visas, regardless of nationality, race or creed.


#### GUARANTEES: CUSTOMS DUTIES, OTHER TAXES, DUTIES AND LEVIES

South Africa aspires to host the 2010 FIFA World Cup.

Further to our commitment to establishing the conditions necessary for organising and staging the 2010 FIFA World Cup, we are pleased to provide the following assurances.

The import and subsequent export of goods belonging to the FIFA delegation, the Commercial Affiliates, the Broadcast Rights Holders, the Media, the spectators and others traveling into South Africa in conjunction with the 2010 FIFA World Cup, such as, but not limited to the following goods, shall be permitted, free of any customs duties, value added tax or other taxes and any other costs and levies:

- personal belongings of all those accredited for the 2010 FIFA World Cup;
- personal belongings of all those accredited for the 2010 Fit A World Cup, technical equipment for players and officials; technical equipment (film and playback equipment, films, lighting, etc.) for broadcast rights holders including, in particular, the entire technical equipment broadcast rights holders including, in particular, the entire technical equipment required by the Host Broadcaster for the production of unilateral television and radio coverage:
- the entire technical equipment as specified by the Host Broadcaster, required for the production and transmission of the multilateral international television and radio signal, as well as for the construction, equipment and operations of the International Broadcast Centre and other broadcast centres at the venues;



#### CUSTOMS DUTIES AND TAXES OTHER TAXES, DUTIES AND LEVIES BANK AND FOREIGN EXCHANGE OPERATIONS (2)

- technical equipment (such as telecommunications equipment, cameras, small computers, etc.) belonging to other media representatives;
- the entire technical equipment required for the production of the official FIFA World Cup film;
- medical equipment and pharmaceuticals for the teams and representatives of the FIFA Medical Committee;
- · food (with some exceptions);
- other technical equipment and material belonging to the FIFA Delegation and the Broadcast Rights Holders, including the Host Broadcaster required in the Headquarters and various organisational centres (such as photocopying machines, typewriters, telefax machines, telecommunication equipment, mobile phones, etc.);
- technical equipment (such as footballs, nets, equipment for the teams, etc.)
   needed by FIFA and/or SAFA: 1
- needed by FIFA and/or SAFA;
  equipment from Commercial Affiliates required by FIFA and/or SAFA for the implementation of any and all Marketing Rights in connection with the 2010 FIFA World Cup, including but not limited to, advertising and promotional material for the 2010 FIFA World Cup (including Preliminary Draw, Final Draw, Workshops and the Final Competition);
- material for the operative implementation of the contracts with Commercial Affiliates (including advertising boards, decorations and promotional material);
- office material for the FIFA general secretariat;
- official awards, trophies, medals, gifts, flags, etc.; and
- any other material needed by the FIFA Delegation and the Host Broadcaster for the organisation and staging of the 2010 FIFA World Cup.

The National Treasury and the South African Revenue Service (and any Governmental authority with jurisdiction over the assessment, determination, collection or imposition of any taxes, duties or other levies) shall not impose any kind of taxes, duties, or other levies on FIFA, FIFA's subsidiaries, the FIFA Delegation and the Host Broadcaster. They shall be treated as tax-exempt persons or entities. In particular, the National Treasury and the South African Revenue Service recognize that FIFA and FIFA's subsidiaries neither constitute a permanent establishment in South Africa, nor are they in any way subject to taxation in the country. The exploitation of FIFA's Marketing and Broadcasting Rights shall not subject FIFA, FIFA's subsidiaries and the Host Broadcaster to any kind of taxation in South Africa. No withholding or source taxes on payments to or from FIFA, FIFA's subsidiaries or the FIFA delegation will be imposed.

The National Treasury and the SA Revenue Service will provide FIFA, the Commercial Affiliates and the Broadcast Rights Holders, including the Host Broadcaster, with the highest level of administrative assistance and support with regard to the handling of any tax issues related to the organization of 2010 FIFA World Cup. We will expedite the provision of advance written, unconditional and binding tax rulings, if required, in order to remove any possible uncertainties on tax issues or charges relating to the organization of the World Cup, its marketing and broadcasting and sale of tickets or entry fees.

In association with the SA Reserve Bank, the National Treasury guarantees the unrestricted import and export of all foreign currencies to and from South Africa, as well as the exchange and conversion of these currencies into US dollars, Euros or Swiss Francs. These currencies shall also be exchangeable in South Africa at the conditions

prevailing on the international foreign exchange market. Furthermore, the Government guarantees to provide written authorisation for payments to be transferred abroad at the official rate.

Should any further concerns on customs duties, taxes, charges or foreign exchange arrangements arise, the National Treasury will promptly assist in addressing and resolving such matters.

We are happy to assure you of the South African Government's full cooperation in ensuring the success of the 2010 FIFA World Cup.

#### RE - SA 2010 FIFA WORLD CUP BID: GUARANTEE TO FIFA

I am acutely aware of the need for the peaceful and orderly running of the 2010 FIFA World Cup. I have directed the National Commissioner of the South African Police Service to make all the necessary arrangements reasonably possible to provide adequate and reasonable security for all guests of the 2010 FIFA World Cup in South Africa.

The Government guarantees to undertake all security measures necessary to guarantee general safety and personal protection, especially at airports, inside and outside hotels, stadiums, training grounds, the International Broadcasting Centre, Media Centres, any official areas and other areas where accredited persons and/or spectators are present.

The Department also guarantees safety and security to the FIFA delegation, media representatives and all accredited persons before, during and after matches, and while travelling in the country

We further guarantee that a detailed written security plan will be developed and implemented in conjunction with SAFA, taking into consideration the experience gained at previous major sporting events, as well as national security guidelines.

Police escorts will be available for the use of teams, referees and members of the FIFA delegation. The precise number and types will be finalised at a later stage in accordance with FIFA's instructions.



As National Commissioner of the South African Police Service, I am fully aware of and recognize the pivotal role of safety and security at the 2010 FIFA World Cup. As head of the main security agency, I will employ the necessary resources at my disposal to ensure the safety of participants and spectators. The South African Police Service has provided security for many incident-free international events. These events ranged from visits by several heads of state to international summits and sport competitions. Audiences and spectators exceeding tens of thousands attended. The successful staging of these events is an indication of the Service's experience in security matters. Consequently, I am confident that the South African Police Service will, under my direction, set up every possible security measure well before the 2010 FIFA World Cup.

I can give you the assurance that all necessary arrangements will be made by the South African Police Service to ensure sufficient security measures.

These measures will facilitate the peaceful and orderly running of the 2010 FIFA World Cup in South Africa. A National JOINTS Priority Committee will deal with security matters at the 2010 FIFA World Cup. 

My Department guarantees to avail at no specific costs to the users of a telecommunications infrastructure, including, but not limited to, all necessary networks (wireless and wireline), terminal equipment and codecs that will enable all kinds of telecommunication, including wire and wireless national and international telephone, data, audio and video exchanges for the 2010 FIFA World Cup. The Department confirms that the telecommunications infrastructure shall conform with the highest standards and requirements applicable at the time of the 2010 FIFA World Cup and shall conform to specific requirements that FIFA may define from time to time.

The telephone infrastructure shall in particular provide at least dual route secured high-speed, high available link circuits between each of the 2010 FIFA World Cup venues, the IBC and International Gateways.



#### TELECOMMUNICATIONS, INFORMATION AND TECHNOLOGY (3)

The International audio and video connections shall provide fully reliable backup connections from the IBC to international cable networks and to the main satellites, including dual up linking facilities (at the IBC and in fixed earth stations)

The users at the 2010 FIFA World Cup shall have state-of-the-art telecommunications technology (for voice and data) at their disposal at all FIFA World Cup venues and offices, including but not limited to the team bases, FIFA headquarters, referees' headquarters, the VIP hotels, the IBC and other Media Centres.

The Department guarantees that it shall provide all assistance reasonably required by SAFA to enable the setting up of an International Broadcasting Centre (IBC)



#### **GUARANTEE TO FIFA**

I, Mantombazana Edmie Tshabalala-Msimang, in my capacity as Minister for Health of the Republic of South Africa, hereby pledge my Department's support to ensure that all required health needs as outlined by FIFA are met to successfully host the 2010 FIFA World Cup. I undertake and guarantee, in the event of the Republic of South Africa being selected to host the 2010 FIFA World Cup, that:

The infrastructure of the South African National Health System, with specific regard to the availability of a comprehensive medical service, (including 24-hour emergency medical treatment) and disaster management, will be put at the disposal of the 2010 FIFA World Cup in the cities where the games will be played. This applies to both foreign and local delegations including the FIFA delegation and representatives, SAFA, players, management and coaching staff, foreign and local spectators, media, sponsors, officials, administrators and the small business sector servicing the spectators at the respective venues.



- The existing health infrastructure will be significantly upgraded in keeping with government's mission to promote the health of all people in South Africa, and to provide caring and effective services.
- The necessary exemptions with respect to accredited foreign medical teams which may include doctors, physiotherapists, etc. who would be permitted to practice only on their own players and other members of their respective delegations, will be obtained from the relevant medical councils in South Africa. Exemption would also be obtained for the relevant medical equipment and pharmaceuticals, a list of which would have to be supplied to the Department before such exemption is given.
