1. PURPOSE

- 1.1 To advise the Minister on the progress of security installation and related work executed by Public Works at the private residence of the President of South Africa, President Jacob Zuma.
- 1.2 To request that the Minister peruse and sign the attached letter and progress report addressed to the President.

2 BACKGROUND

- On or about August 2009 a project was initiated to design and execute security and related work at the above project. Due to the high profile and prestige nature of the project, the acting Director-General at the time and the Chief Operating Officer were delegated the responsibility to oversee the project and to support the Durban regional office with the execution of the works.
- 2.2 The general scope of the works is to provide security installation as prescribed by the Director for Internal Security in the Presidency, South African Police Services security advisory services (SAPSS: SAS) and the National Intelligence Agency.
- 2.3 On or about the end of June 2010 it became evident that some of the major activities related to the security installation had not progressed to the extent as was originally envisaged. It was at this stage that the Deputy Director-General, Inner City Regeneration, Project Management and Professional Services was requested to intervene and the following key outstanding items were found to be delayed:
 - 2.3.1 Specifications as approved by SAPS: SAS had not been actioned, i.e. the specifications were not converted in to tender documentation for procurement purposes.
 - 2.3.2 The contract for the emergency building related work had at that stage not been awarded.
 - 2.3.3 A specialist security consultant had not yet been appointed.
 - 2.3.4 The procurement for the inner high security fence (specialized installation) had not been finalised.
 - 2.3.5 The procurement for the bullet resistant glass had not been finalised.
 - 2.3.6 The procurement for high impact glass had not been finalized.
