Thanks, brother!

I appreciate your message and the work you are doing to enable this to become a reality.

Is there anything that Aloga can do to help them? Do you have your 10% of interest revenues available? Does the Aloga board see this as an initiative they would want to get behind to make happen?

Keep in mind that whatever number are selected to come (up to a maximum of the 6 we agreed to), PEER Servants will commit to raise 50% of their support. So, if 4 plus Sphiwe come, again -- we will raise 50% of the \$2,500 budget per person, assuming they first raise their 50% (\$1,250).

You can then apply the 50% per person they raise (\$1,250) to the airplane ticket. If additional funds are needed for the ticket (which they will presumably be), that is when we will provide our piece to help cover the remainder of the ticket. What you cannot do is wait until it is too late and have the ticket prices go way up, so that's why it is urgent for Aloga/TRM to not only pick who will come but make certain they have the funds needed to come (at least their half).

We will continue to pray to that end and that Satan will not thwart what could be a very exciting event here in advancing the Kingdom.

Re **Update on Aloga projects and request for donation**

We hereby wish to once again convey our heartfelt thanks for your previous donation during our International Kopano conference. We would not have been able to hold such a successful conference without your assistance together with other donors.

On a lighter note, Kopano conference did not only bear fruit to introduce various international micro enterprise entities to each other but also produced a couple who met at the conference and subsequently married. The couple is from Brazil and United State of America respectively. For information relating to Kopano conference you may consult the website of our donors in the USA namely;

As previously mentioned to you during our various meetings, Aloga continues to touch the lives of the poor through access to micro finance. This is in line with our government policy to reach out to those belonging to what is termed "the second economy". We have been able to finance over 100 micro businesses so far in 2006. Considering the fact that these businesses belong to individuals who invariably are also breadwinners, majority being women, this culminates to almost touching 300 to 400 family members if dependents are taken into consideration.

We are happy to advise you that our efforts to empower emerging entrepreneurs and alleviate poverty have not gone unnoticed. The Department of Trade and Industry initiated South African Micro Finance Apex Fund (SAMAF), has identified Aloga as a partner organization. As you would know from our various discussions that our greatest challenge was to meet our monthly overheads and capital requirements. SAMAF will be meeting these overheads and loan capital requirements with effect from June 2006. This has enabled us to employ two full time young people as Business Development Officers (BDO's).

We have further established a youth organization known as Tide Rescue Mission (TRM). The objective of TRM is to reach out to the youth by way of awareness campaigns in particular moral regeneration, drug addiction challenges, alternative beneficial life changing choices and urban and rural mission activities. In achieving this goal we established the annual Aloga Cup, which is a soccer tournament for young people from Mamelodi. The inaugural Aloga Cup was successfully held during August 2006 at HP Pitje football grounds. We hope to improve on the prizes for the winners next year as we could only afford to give out a trophy to the winning team and provided refreshments to all the youth attending.

It has become imperative for the youth in TRM to receive training in performing their activities and to this end we were able to identify a relevant International Youth Mission conference taking place on 23 December 2006 to 2 January 2007 at St. Louis, Missouri, USA. This conference will benefit our young people with life skills and exposure on the current approaches to missions world wide. We are intending to send about six young people who on their return are expected to share and utilize their experiences to reach out to the young people in the township.

Our donors in the USA namely, Peer Servants have undertaken to raise 50% of costs involved which is half of \$2500 USD per person inclusive of traveling and accommodation. We still have to raise 50% for each young person before 30 November 2006. As one of our previous donors, we considered it necessary to approach you if you could be of assistance in this regard. We will appreciate whatever contribution you may put forward as we have also brought this to the attention of our previous corporate donors. We attach the relevant e-mail from Peer Servants wherein they undertake to make the aforesaid portion for your information. Kopano conference was the inaugural conference of the International Micro Enterprise Development partners. We agreed at that conference that we would be holding such conferences tri-annually. As you would have noted our conference was attended by delegates from inter alia, USA, India, Nigeria, Sudan, Angola, Namibia, Moldova, Vietnam, Sri-Lanka, Brazil, Thailand, Peru and Haiti. It was resolved during the Kopano conference to hold the second conference in Peru in 28 July to 8 August 2007. We are therefore preparing in advance for this conference. In as much as delegates from the above-mentioned countries honoured us by attending and further bringing their countries memorabilia for display and promotion of their countries of origin, we also intend sending at least six delegates to what has been termed the "Ricchari" (which means Awakening) Conference with South African memorabilia and related cultural goodies to promote our country and Aloga.

We shall be raising funds to enable our delegates to attend the conference and it for that reason that we considered necessary to inform all our previous donors in time in the same manner as before our Kopano conference. 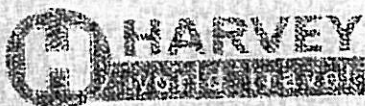
